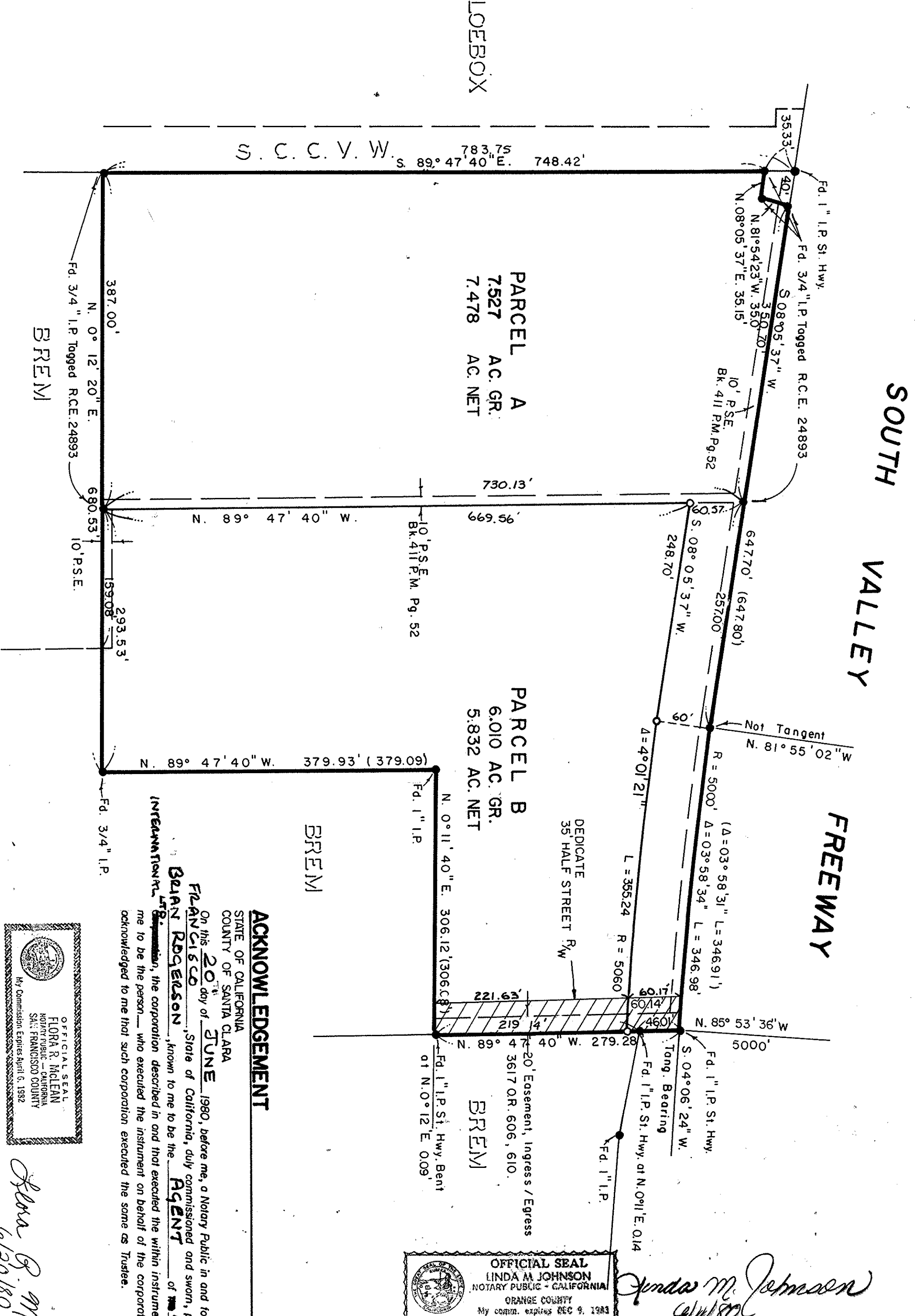
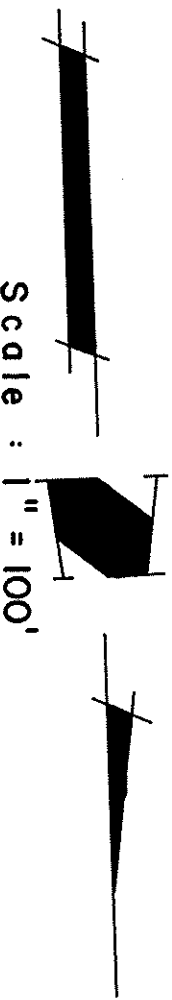
BASIS OF BEARINGS

IN THE CITY OF GILROY

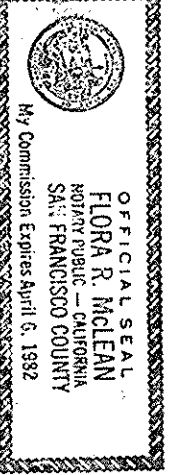
